## Update on Fire Incident at one of unit at Rajkot, Gujarat No Casualties or Injuries Among Personnel Onsite

**Rajkot, 12<sup>th</sup> December 2024:** Gopal Snacks Limited, ("Gopal Snacks Ltd" or the "Company") (BSE: 544140; NSE: GOPAL), informed stakeholders yesterday of a fire incident at one of unit located at Plot No. G2322-23-24, GIDC Metoda Tal. - Lodhika, Rajkot, Gujarat, India, 360021.

As an update, the Company has taken the appropriate measures to manage the incident and there have been no casualties or injuries among its personnel onsite. The safety of Gopal Snacks team members always remains its highest priority.

Given the situation, the Company has implemented the following measures:

- Production activities have been scaled up at Modasa and Nagpur facilities to compensate for the current closure of the Rajkot I facility. Additionally, the Company is engaging with third-party manufacturers to the extent additional local capacity is required
- The company's assets are fully insured, and the insurance provider has been notified of the incident.
- All critical business systems, including SAP infrastructure, remain operational and secure, ensuring seamless business continuity without any data loss. There has been no loss of data or disruption to our IT systems.

The Company is working diligently to restore operations at the Rajkot I facility at the earliest. Management is confident that this incident will have no significant long-term impact on the Company's operations or financial performance.

Gopal Snacks will continue to provide regular updates on the situation and as the operations at the Rajkot I facility normalize. Most importantly, no casualties or injuries were incurred onsite during the incident.
